## PUBLICATION REQUIREMENTS

For publication purposes, the following requirements shall apply:

The first page must include the full title of the paper, the authors' names, their professional or academic affiliation, as well as their e-mail addresses. The title must be provided in both Romanian and English.

Submitted papers should not exceed 20 pages. The abstract must be accompanied by relevant keywords defining the content of the article.

## FORMATTING RULES

Only Word format (.doc/.docx) is accepted.

The text must be formatted with justified alignment, using 1.5 line spacing, 12-point font size, Times New Roman, and margins of 2 cm.

The use of the following is not permitted: section breaks, page breaks, headers, and footers.

Each citation must be accompanied by a proper reference to the cited source. Each new paragraph must be indented.

## CITATION RULES

Submitted articles must comply with the following citation requirements:

1. Books: Author, Title, Publisher, Year, Page.
2. Articles: Author, "Title", Journal, Issue (if applicable), Year, Page range.

Where articles, reports or official documents available online are used, they shall be cited in accordance with the above rules, with the addition:

*"available online at [full URL]", indicating the date of last access.*



## BIBLIOGRAPHY

The bibliography shall include only references to relevant academic works and articles, listed in alphabetical order and subsequently in chronological order.

All bibliographical references must be numbered.
